New This Release

8.0.116.0	Added Servis First Positive Pay Added Servis First as a Positive Pay option to the check tab in Lockdown options.
8.0.120.0	Improved Product Importing In Lockdown Lockdown will now wait a configurable number of minutes before attempting to import, this should prevent importing an incomplete file. Lockdown will now archive successful product files and mark failed files in the failures folder.

Enhancements

8.0.118.0	Added Multiple Line Skips To Generic JMS Generic JMS can now skip more than just the first line in the JMS import using the LineSkips option in the template file.
WEB	Added Disclaimer To Edit Facilities Page A configurable Email Disclaimer option has been added to JailATM.com. JailATM.com users will see the disclaimer in all email communication with residents, and while composing an email from the Compose Message page. This option must be coordinated and activated through Tech Friends.

Fixed Known Issues

8.0.117.0	Fixed Deposit Detail Report Yielding Inaccurate Subtotal Fixed the following issue: If the last transaction type on the deposit detail report only had a single transaction, the subtotal from the previous type would be used instead.
8.0.119.0	Scheduled Payments Now Correctly Display The Right Range Scheduled payments will now correctly display the date range for the period that the payment is covering instead of showing the last day of the payment.
8.0.122.0	Payroll Reports Now Support Jobs By Days Worked And Days Assigned Payroll using paygrades that have Days Worked and/or Days Assigned now store correctly in the database. Reports have also been modified to include columns to show the amount of days the inmate is getting paid for.
8.0.122.0	Max Order Amount Removed And Replaced With Restriction Max Order Amount has been removed from Lockdown options and has been replaced with a restriction option.
8.0.123.0	Fixed The Option "Immediate Onsite Posting" Fixed the issue where the option "Immediate Onsite Posting" would combine offsite and onsite orders onto an onsite invoice during posting.
WEB	Fixed An Issue With Call Scheduling Limits Fixed the following issue: In certain scenarios call limits might not have been enforced if they were scheduled at the end of one month a week in advance for the beginning of the next month. For example on August 26th a call was scheduled for September 2nd. This would not have enforced call limits property.
