7.0.1112.32	ATM - Bill acceptor - Fault Tolerance Enhancements Reduced the possibility of a faulty bill acceptor causing cash deposits to not be credited to a resident account.
8.0.246.0	Lockdown - JMS Interfaces - Spillman Web Service Bonding Interface Added a bonding interface that is compatible with Spillman Web Service 6.2 +
8.0.278.0	Lockdown - Work Release - Custom Work Release Collections Added a feature to enable customization of Work Release Fees and Collections. Added new "Simple" mode to the work release paycheck screen to make using the feature easier.
WEB	JailATM.com - Sort Workflow Responses - Option for Sorting the Workflow Responses Added a button that will sort the workflow issue details in either ascending or descending order.

ACH imports are no longer moved to the failures folder when they fail due to a timeout. This causes the system to import them once the timeout is resolved.

WEB JailATM.com - User Permissions - Independent Permissions

Edit Schedules, Assign List Editing, and Search Web Pack are no longer dependent on

the user having other permissions and can be assigned independently.

WEB JailATM.com - Workflows - Designation of Reassigned Issues

Added a new column to the assigned workflows list showing the last person assigned to

the task. Added a new list to show tasks that have been reassigned to the user.

WEB JailATM.com - Kiosks Software - Multi-line Prompts

All Kiosks now support multi-line prompts in workflows.

WEB JailATM.com - Reports - Workflow Interaction Report Reformatting

Added new options when running the Workflow Interaction Report. One option will integrate officer comments into the workflow while the other will put a page break after

every workflow.

Fixed Known Issues

8.0.269.0 Lockdown - Checks - Long Comments

Added new options to allow multi-line comments in the check memo area to prevent an issue that could cause check information to shift down with longer comments.

8.0.271.0 Lockdown - User Permissions - Stash Transactions

Changed the Stash Transactions permission so that a user having this permission has

access to the Cash Drawers menu without other having permissions.

8.0.277.0 Lockdown - Debit Time Interface - Debit Time Balance Hidden

Fixed an issue that hid the debit time balance for certain phone interfaces. This fix should prevent this issue from happening to other new or existing debit time interfaces.
